Signage grants are awarded up to \$1000.

This competitive grant is locally funded by the Main Street Centerville Program. Grant applications are reviewed and awarded at the discretion of Main Street Centerville Design Committee. The application must be completed in full when submitted, or the project will be ineligible. If awarded, the check will be submitted directly from PACT to the vendor(s).

Desired Type of Signage

Please note your desired signage improvements. *see attached sheet for reference images & scoring rubric.

___ **Flush mounted sign:** Typically attached to the building above the storefront or awning of a business. The sign should be mechanically fastened to the mortar joints and not to the brick or stone.

___ **Projecting signs:** Projecting signs with armature add business visibility on narrow streets and the pedestrian realm.

___ **Individual letter signage:** Often referred to as dimensional letter signs, each letter is individually mounted to the building, above the storefront. They can either be mounted directly to the wall or installed with stand-offs or pins for added depth.

___ **Window Vinyl and/or Sandwich Boards:** If your primary signage is in good condition, up to City Code & appropriate for your building, you can apply for these funds to be put towards secondary signage including window vinyl and/or sandwich boards. If your primary signage request for this grant is less than \$1,000, you can also apply for secondary signage as long as the total request (for both primary and secondary signage) does not exceed \$1,000 per building.

- All designs must look like original works of art. Clip art or common graphic designs will be returned with change requirements.
- This grant opportunity is only available to businesses or building owners in the Main Street District.
- Compliance with Centerville City Code and ensure signage permit is obtained. Details are listed on following pages.
- Submit current photographs of your building, as well as sketches and estimates of the proposed signage.
- Attached we have included a list of local trades vendors who are PACT members for your convenience. If you work with another vendor, please submit their business information with the application.
